### ALABAMA SUPREME COURT AFFIRMS LIGHTFOOT'S SUMMARY JUDGMENT FOR NBC AFFILIATE IN DEFAMATION CASE

The Alabama Supreme Court has affirmed on appeal a summary judgment obtained by Lightfoot, Franklin & White LLC partners **JT Thompson** and **Jonathan Little** on behalf of NBC affiliate WLTZ NBC News 38 in a notable defamation case. The court's decision effectively dismisses a series of defamation and fraud claims against the NBC affiliate regarding its reporting on charges against a criminal defendant.

The plaintiff, a criminal defendant accused of sex crimes against minors, alleged claims of defamation, fraud and damages after the news station reported the charges levied against him. Lightfoot's lawyers took a unique approach in fashioning a two-phased scheduling order to re-focus the case on the truth of the article, which allowed them to file summary judgment after the first phase of discovery concluded. After a thorough presentation of evidence during the summary judgment hearing at the Lee County Justice Center, the trial judge granted the NBC affiliate's motion for summary judgment, holding that WLTZ NBC News 38's coverage was not defamatory in any way.
