### B-METRO MAGAZINE NAMES LIGHTFOOT PARTNERS 'TOP WOMEN ATTORNEYS' FOR 2020

Eagan became Lightfoot's first female managing partner in 2018. She has decades of experience in high stakes product liability and catastrophic injury cases and has successfully tried numerous cases to verdict throughout the Southeast. She also regularly represents medical providers in malpractice cases, as well as serves as appellate counsel for a number of clients. *Benchmark Litigation* recognizes Eagan as a "Top 250 Women in Litigation" and a "Litigation Star." She is listed in *The Best Lawyers in America*® and *Mid-South Super Lawyers*, as well as being recognized as an Elite Boutique Trailblazer by the *National Law Journal*.
