He served as president of the Downtown Kiwanis Club in 1990 and as president of the Civic Club Foundation in 1991. He was Chairman of the Board of Trustees of Independent Presbyterian Church in 1995, and in 2009-010, he served as president of the High Hampton Colony Club in Cashiers, North Carolina. Warren is a bronze sculptor. His portrait busts are displayed in the U.S. Supreme Court building, in the Supreme Court Historical Society Headquarters, in the Supreme Court of British Columbia building, in the Alabama Supreme Court building, in the University of Alabama at Birmingham's O'Neal Comprehensive Cancer Center, in the High Hampton History Museum, and in the senate lobby of the Alabama State House.
